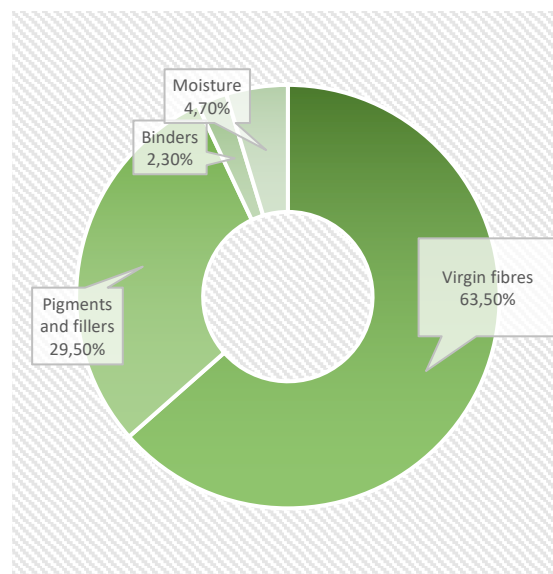

Company systems ensure traceability of the origin of the wood

LECTA - TORRASPAPEL guarantees that the timber it uses to manufacture its products is responsibly sourced and is able to provide evidence that this wood comes solely from legal, non-controversial sources, all of which are certified or controlled. Proof of this are the PEFC and FSC chain-of-custody multi-site certifications held by all of its manufacturing sites.

In 2025, LECTA - TORRASPAPEL consumed a total of 416,885 m³* of eucalyptus wood from Spain and Portugal in the manufacturing of pulp at its Sant Joan les Fonts mill. All of LECTA - TORRASPAPEL's pulp production is designated for internal use and represents 38% of the cellulose pulp required to manufacture its paper. The remaining pulp is purchased from external suppliers that must state the percentage of cellulose provided that comes from certified wood sources, the type of certification applying to items concerned, and the origin of the wood (forests, plantations, sawmills).

In 2025, 100% of purchased pulp was certified in accordance with one of the existing market certification schemes (FSC, PEFC).

Environmental Parameters

Note 1: Environmental parameters include more than 95% pulp consumption.
